# **Hudson Valley Tech Meetup**

Mr. Kale Kaposhilin provided an overview of the Hudson Valley Tech Meetup group. The group has been in existence for one year and brings together technologists from the Hudson Valley area. Meetings occur once per month. Mr. Kaposhilin proposed a small sponsorship from the UCEDA to support the Hudson Valley Tech Meetup group. Additionally, a representative of the UCEDA was requested to attend "Meetup" events to meet with developers. The next event is scheduled for April 29. 2015.

#### StateBook

Calandra Cruickshank provided an overview of her company stating it is the first online platform to assist companies in their process of finding suitable locations within the United States. Ms. Cruickshank provided a demonstration on the capabilities of her program. StateBook has aggregated 20,000 data points by county for every community across the United States standardizing data so comparisons, searches, and filtering can be done with the data by multiple means. Reports can easily be generated with data exported into EXCEL format. Ms. Cruickshank expressed that when an economic development organization joins as a member their contact information is combined, the agency will be able to add their own editorial content (photos, charts, graphs), and 20,000 data points will be available for their communities. The cost of StateBook is based on the state gross domestic product and percentage of local population; for Ulster County the cost would be \$2,500 per year.
